Our Background

Rotherfield Pre-School is a non for profit charity, meaning that any profits are invested in staff, staff training and equipment for the children. We have been running since 1969 and made the move to our own, purpose made premises in January 2011. We are lucky enough to employ an exceptionally experienced and highly qualified staff who are extremely dedicated and devoted to the children. The day to day running of the Pre-School is the responsibility of the manager and the staff, however, overall responsibility for the management of the Company lies with the Board of Directors. We are an incorporated company meaning that each board member is only personally liable for £1.00 in the event of any litigation. The Board of Trustees can run from a minimum of 3 members namely, the chair, treasurer and manager, to a maximum of 8. We typically run between 4 – 6 members.

Becoming a member of the Board of Trustees.

We are very fortunate that our Board of Trustees consists of parents and staff which means we are a very passionate, dedicated and hands on team with every aspect of the day to day running of the pre-school. As a parent you are eligible to apply for the role of director. Your application will be considered by the current Board of Trustees. There are many roles within the Board of Trustees, each with its own level of commitment. Namely, these roles include:

POPs (Parents of Pre-school) Co-ordinator
Publicity Co-ordinator
Grants Co-ordinator
General Member

You will be required to attend a monthly meeting usually during the day and you will be required to complete a form for Ofsted (EY2), undergo a DBS check and complete online Safeguarding and Directors training.

What happens next:

Your application will be considered and if successful, you will be notified by email. You will then be given details of where to complete the online EY2 (Ofsted) form. As part of this process you will be directed to complete the DBS section. **You will required to make payment, please take a copy of this screen so that you can claim back as an expense.** You will be directed to show ID to an appropriate person. Once processed the Manage will receive a letter from Ofsted to advise that you are suitable to become a director (this process can take a few weeks). Our secretary will then log your details with Companies House and the Charity Commission. Due to safeguarding you are unable to attend any directors meetings until all the above processes have been completed.
